**NOTIFICATION**

In exercise of the powers conferred by sub-sections (1) and (2) of section 8A of the Assam Right to Public Services (Amendment) Act, 2019, the Governor of Assam is hereby pleased to constitute a body, namely: the Assam State Commission For Right to Public Services to exercise the powers conferred on, and to perform the functions assigned to it, under the said Act. The Assam State Commission For Right to Public Services shall consist of-

- (a) **The Chief Commissioner; and**  
(b) **Two Commissioners**

The appointment, the term of office and conditions of service of the Chief Commissioner and Commissioners shall be such as laid down under the provisions of the said Assam Right to Public Service Ordinance 2024.

The head quarter of the **Assam State Commission For Right to Public Services** shall be in **Guwahati**.

This notification shall come into force with immediate effect.
